- 1. Mr. Rhodes discussed the SAGR (Submerged Attached Growth Reactors) System with the board. He brought a pamphlet that described the system, which consists of clean stone bed that is fully aerated and would help with the ammonia levels. The Board will be weighing costs and continuing discussions with Moberly, who is receptive to our connection to their sewer system, to determine the best long-term plan for the best interest of the Village of Cairo residents. Repair of manholes needs to be done as soon as we can. Guests that were present raised concerns about increasing rates. Clint explained that we have not increased rates again for about five years and in order to maintain the sewer, increasing rates regularly is just part of the process.
- 2. Clint Cross spoke with DNR about the flooding complaints near Keller.
- 3. Residents are still wondering why the road that was torn up has not been fixed.
- 4. Comments were made by a guest that one of the board members was making false accusations. The board member who was accused called a witness who stated the rumor was false.
- 5. Tim Zike would like us to look into insurance coverage for the mold damage to his baseballs during periods of no air or heat in his side of the building.
